This bridal service contract is made and entered between "Bride" _____
whose phone number is _____ and "artist" Heather Griffith.
Heather is not an agent or employee of the bride. The parties intend that an
independent contractor relationship will be created by this contract.

In consideration of the mutual covenants herein contained and, intending to be legally bound
herby, the Client and Artist agree as follows:

1. Location: Preparation will take place at the following
location: _____ (preparation
will take place at only one location until all services are completed)
Artist will travel in a 50 mile radius from James Atelier salon without an additional fee.
However, after 50 miles it is a \$1 per mile charge from James Atelier salon to said
location and back. There are additional travel fees if artist(s) needs lodging for this
special event.

2. **Date** of wedding and **time** the bridal party needs to be ready by (please refer to wedding
coordinator and photographer for correct time): _____

3. Services Requested:

There is a \$560 service minimum which does not include \$100 booking fee

Bride: Hair \$150 _____
Bride: Hollywood waves (need 1-1.5 hours) \$200 _____
Bridal Makeup: \$150 _____

Bridal Party and/or Family Members: Hair \$130 _____(number of services)
Makeup: \$130 _____(number of services)

Flower girls (ages 10 and under): Hair \$100 _____

4. In full consideration for all services rendered by the Artist at the location, the Bride agrees to
make the payment in full in U.S. funds with Cash or Card (Mastercard, Visa, Discover or
American Express) one week before date of the wedding.

If the artist(s) travel out of town, the travel fee is due **two months** before wedding date
which covers lodging and other expenses.

Booking fee: \$100 **NONREFUNDABLE** booking fee required in order to secure the wedding
date. If Heather needs to bring another artist, there is a \$100 booking fee for each additional
artist. Payment may be made in U.S. funds with Cash or Card (Mastercard, Visa, Discover or
American Express)

__(Initial) I understand and agree that booking fee is nonrefundable and this is separate from
service total.

5. Cancellation Policy (bride): Cancellation will result in forfeiture of the above mentioned
booking fee. **After final number of services are confirmed on the contract, any services on
the day of can not be cancelled.** If so, it is the responsibility of the client to pay the original
amount for the service (\$130) in order to fill the empty time slot(s). If bride want to add a
service, client must talk to artist(s) ahead of time to ensure there is enough time allotted.

If bride needs to change original date, artist will allow one date change as long as artist is available. New contract will need to be filled out and retainer will be secure for **one** date change.

__(Initial) I understand and agree the cancellation policy.

6. Cancellation Policy (artist): Artist's obligation to give services hereunder is subject to the unavailability of the artist as a result of sickness, accidents and any other reasons beyond the Artist's control. In case of such event, artist will reimburse bride with full booking fee and will provide referrals for a replacement artist

7. MISCELLANEOUS: This agreement constitutes the entire agreement between the parties and may not be amended except in writing signed by both parties.

8. ADVERTISING

Bride agrees to allow artist Heather Griffith to take before and after pictures to use for promotional use in advertising on social media, website or other materials.

9. EXTRAS:

***If bride is interested in a hair or make-up trial, these are additional costs**

*Artist is not responsible for any damage to eyelash extensions

*Bride agrees to immediately inform artist(s) of any sensitivities or allergies they may have to any types of makeup, products or treatments

*Bride agrees to inform bridal party or other family members to inform artist(s) of any sensitivities or allergies they may have to any types of makeup, products or treatments

*Bride agrees to not hold Heather Griffith or any assisting artist(s) responsible for any allergic reactions developed as a result of the make-up application or hair products that may occur to bride or bridal party

*Please steam dresses **BEFORE** hair and makeup appointments. Artist, Heather is not responsible for any touchups/redo's due to damage from steam

*Each person must have CLEAN, cleansed/moisturized skin and 100% dry hair for their appointment time. Any blow-drys required will cause delays in the schedule and will require a **\$20 additional fee**

*If anyone has naturally extra curly hair and does not want to use their natural texture for services, it is their responsibility to smooth their hair with a blow dryer before their appointment time so artist can use hot tools to style

*Be sure everyone arrives on time and is ready for their appointment slot. Artist is not held responsible for delays made by persons who arrive late or are not ready

10. Assistants: If an assistant is required or requested, Bride is responsible for additional booking fee and travel fee as well as parking fees for assistant(s)

FYI: Hair and makeup prep tips

*Pictures are always helpful. Be sure to bring along photos that you like and do not like so we can pick a style that suits your own tastes, as well as what works with your hair texture, color, length, etc

*Extensions are always recommended(real hair, not synthetic). If you're using brand new extensions, be sure to wash and dry them before the first use. This will help your style hold longer. Do not use any oils or serums, and be sure not to flat iron them before use (this will also make your curls fall faster)

*Oily/greasy hair is extremely hard to style, tease, form, etc. Clean hair is preferred, however if you truly prefer dirtier hair, please be sure it is NO MORE than 1 day dirty. Also, please don't put any product in your hair beforehand other than mousse prior to blowdrying

*Please don't use any sunscreen on your face before makeup application. Sunscreen can create a flashback in photos. Artist will prep your skin with moisturizer, etc.

11. SEVERABILITY: Should any provision of this Settlement Agreement and Full and Complete Release be declined or be determined by any Court of competent jurisdiction to be wholly or partially illegal, invalid, or unenforceable, the legality, validity, and enforceability of the remaining parts, terms, or provisions shall not be affected thereby and shall remain in full force and effect.
